Structure, governance and management

The Trust Deed is dated 3 December 1997, and the charity was registered on 22 July 1998.

The management of the Trust is carried out in accordance with the Trust Deed, and in particular, when it is necessary to appoint a new trustee, a Special Meeting of the existing Trustees is held to discuss and agree any appointment.

Many of the Trustees, including the two who were appointed during the year, have had experience of running various aspects of one of the university branches, and/or many have experience of visiting and working with the NGOs we support in various countries.

Most of the Trustees stay in the post for more than four or five years, but inevitably people have, sometimes, to move on as their job moves to another location or they acquire other time-consuming responsibilities.

While this is not a requirement of the Trust Deed, the trustees themselves donate the money to cover all the expenses involved in running the Trust, so that we can say honestly that "ALL the money raised by the branches, and other money donated, goes directly to the charities/NGOs we support".

Risk management

In relation to the Trust Funds, the trustees seek to minimise any risk which would prevent us from sending the funds raised to the NGOs we support. In particular we have taken steps, as discussed under our grant making policy, to smooth out the spikes in our income (which are unavoidable) so that we can offer consistent support where we have promised to do this. In addition we keep in close touch with our branches to ensure that they are properly, ethically and responsibly run, and that they keep appropriate records of their activities.

Objectives and activities

The Trust objectives are:

- to promote any charitable purpose for the benefit of 'street children', and in particular, but without prejudice to the foregoing
- to relieve poverty, sickness and distress;
- to preserve and protect health; and,
- to advance education.

Its area of operation is worldwide.

The Trust is run by a group of Trustees who meet about eight to ten times a year to coordinate the activities of branches. Each branch is run by its own committee with the twin objectives of raising awareness amongst students about 'street children' issues, and of raising money for the NGOs we support who are working to improve the prospects for the street children in their area.

The branches encourage students to get involved:

- in understanding the situation of street children in different countries; and,
- in taking action which will help the children to have opportunities for education and healthcare by raising funds which are in turn used by local NGOs who work effectively to provide appropriate facilities and support.

At the year-end, there were SSSK branches in:

Bristol University
Cambridge University
Durham University

Edinburgh University, and

Oxford University

and at

St Paul's Boys School in London, and

St Paul's Girls School in London.

We are actively looking to increase the number of universities and schools where SSSK can be represented. We are members of the Consortium for Street Children: the only network working to promote and protect the rights of street children on a global scale.

The Trust maintains a website whose prime aim is to provide background information for students. It is continually updated with recent resources and articles about work done by various NGOs with street children, and studies undertaken by organisations such as UNICEF. The site also provides information about the activities of the NGOs we support, and a contact point with the trustees.

Grant making policy

The policy of the Trust is to support NGOs who have been visited by SSSK members. We also try to provide consistent and sustainable support wherever possible. We normally meet once a year during the summer to determine our grants, following the circulation of a discussion paper.

During the calendar year 2007 we approved grants totalling £25,000 to twelve different NGOs in Cambodia, Colombia, Ecuador, Egypt, Ethiopia, India, Kosovo, Peru, the Philippines, Sudan and Vietnam. Some of this was in the form of ongoing grants, and some donations were regarded as being a 'one-off'. The majority of these grants were paid out before the end of the financial year, to the value of £19,100, while the others were paid just after the financial year end and will show in next year's accounts.

As our income has been very spikey, and we were holding a significant balance in order to provide consistency to particular NGOs during the next two or three years, we were able to offer a short-term loan of £10,000 to the Consortium for Street Children who had a temporary funding crisis. The loan was for one year, and its repayment was personally guaranteed by two of the Consortium trustees. It will in fact be repaid in March 2009, four months early, so the money will be available in good time for our 2009 grant making

decision. The Consortium's activities are directly in line with SSSK's own objectives, and the Trustees were pleased to be able to help in exceptional circumstances.

Achievements and performance

The trustees and the branches have had a busy year. During the year the Trust was presented with an award from the Centre for Children's Rights in Pristinha, Kosovo for its support of Children's Rights in the country, and its support for the Centre.

All the branches managed to maintain their level of activity, although as with all student organisations there is a yearly change of personnel, and branch sustainability and the gathering of a new committee to take it on during the following year is an ongoing challenge.

Financial review

As this is only the third formal Trustees Report to be submitted to the Charity Commission with certified Financial Statements, it is worth reviewing the recent history of the Trust. The gross income and expenditure of the Trust during the (financial) year ending in October 15th in each case is as follows:

The financial statements submitted here for 2008 show the gross income of the Trust to be £18,553 and expenditure to be £30,130. The sudden annual increase in 2007 was the result of a contribution from a one-off event, as explained in last year's Annual Report.

This year we have received income from two new sources, as we had a runner in the London Marathon raising sponsorship for SSSK, and an organisation called Busking for Street Children approached us and asked if we would distribute the monies they raised to the NGOs we support.

Within these figures, all the direct expenses incurred in running the Trust are paid for in full by contributions from the Trustees themselves, as stated under Structure, governance and management.

In the Financial Statements, the monies coming from the branches are described as 'Restricted Funds' all of which go to the NGOs, while the money contributed by the Trustees is described as 'Unrestricted Funds' which can be used as necessary to cover the direct expenses involved in running the Trust and its website. It was agreed that all Gift Aid reclaims should be allocated to restricted funds.

Investment policy and performance

The Trusts funds are held in an interest bearing account with the Charities Aid Foundation, and this resulted in a useful £1,376 contribution to our income.

Reserves policy

The Trust does not intend or need to hold any long-term reserves, as our funds are intended to go directly to the NGOs we support. However, because of the spikey and slightly uncertain nature of our income, the Trustees decided to smooth out the grants made over a two or three year period as discussed under our grant making policy.

Plans for the future

The Trust aims to ensure, as far as possible, the sustainability of the various branches in both schools and universities, and to look for opportunities for starting new ones. It aims to grow organically, and at a pace which it can sensibly cope with.

The Trust is anxious to ensure consistent support to the main NGOs which it supports, although one-off grants are considered where appropriate. It seeks to maintain as far as possible the personal links with the NGOs supported, and either Trustees or student SSSK members are encouraged to visit whenever possible (albeit at their own expense).

Many students are interested in volunteering in various ways both as a direct way of helping development work and of learning more about it. While we are not able to offer volunteering opportunities ourselves, we are building a list of appropriate NGOs who offer such opportunities. We are passing this information on to any student enquirers.

Trustees' responsibilities

The trustees are responsible for producing the Annual Report and accounts in accordance with applicable Law and United Kingdom Generally Accepted Accounting Practice. Charity law requires the trustees to prepare accounts for each financial year which give a true and fair view of the state of affairs of the charity and of the results of the charity for the year. In preparing these accounts, the trustees are required to select suitable accounting policies and to apply them consistently; make judgements and estimates that are reasonable and prudent; and prepare the accounts on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The trustees are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the charity. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

I report on the accounts of the Trust, charity number 1070646, for the year ended 15 October 2008, which are set out on pages 7 to 9.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts. Notes to the Accounts

Year to 15 October 2008

1. Trust History

Students Supporting Street Kids is governed by a Trust Deed dated 3rd December 1997, and was registered with the Charity Commission on 22nd July 1998 (registration number 1070646).

2. Principal Accounting Policies

a) Accounting convention and basis of preparation The accounts have been prepared under the historical cost convention, and in accordance with applicable Accounting Standards.

The charity has adopted as far as practicable the updated Statement of Recommended Practice for charities issued in 2005 and the Charities Act.

The financial statements of Students Supporting Street Kids for the year ended 15 October 2008 comprise the statement of financial activities (SOFA) and the balance sheet.

b) Incoming resources and resources expended
These accounts have been prepared on a receipt and payment basis and reflect all
incoming resources and resources expended over the trust's financial year.

c) Fund accounting Restricted funds can only be used for particular restricted purposes within the objects of the Trust. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Unrestricted funds are those funds which can be used in accordance with the charitable objectives of the Trust at the discretion of the Trustees.
